

# Sumitomo Pharma Oncology, Inc. Website Privacy Notice Supplemental Notice for California Consumers

[Last Updated 4/1/2022]

<p><b>Why?</b></p>	<p>The California Consumer Privacy Act of 2018 (CCPA) gives California residents the right to know what Personal Information Sumitomo Pharma Oncology, Inc. collects about them, including whether it is being sold or disclosed to third parties. The CCPA also grants certain rights to California residents, including the right to delete their Personal Information (subject to certain exceptions) and the right to prevent Sumitomo Pharma Oncology, Inc. from selling their Personal Information. Companies are also prohibited from retaliating or discriminating against consumers for exercising their rights under the CCPA.</p> <p>All companies need to collect and share consumers' Personal Information for everyday business purposes, marketing, and maintenance of the safety, security, and integrity of their websites and other assets, among other reasons. This Supplemental Notice provides the information required under the CCPA and applies to both Sumitomo Pharma Oncology, Inc.'s online and offline activities. <p><b>What?</b></p>	<p>The types of Personal Information we collect, disclose, and sell depends on your relationship and interaction with Sumitomo Pharma Oncology, Inc. <p>Your Rights</p>	<p>If you are a California resident, you have the following rights under the CCPA with respect to your Personal Information:</p> <ul style="list-style-type: none"> <li>• <b>Right to Notice.</b> Before or at the time we collect Personal Information from you, you have the right to receive notice of the Personal Information to be collected and the purposes for which we use it. This Supplemental Notice is intended to satisfy this requirement.</li> </ul> <p>You also have the right to request that we disclose to you the categories of Personal Information we have collected about you in the preceding 12 months, along with the categories of sources from which the Personal Information was collected, the purpose for collecting or selling the Personal Information, the categories of third parties with whom we shared the Personal Information, and the categories of third parties with whom we sold the Personal Information.</p> <ul style="list-style-type: none"> <li>• <b>Right of Access.</b> You have the right to request that we disclose or provide you with access to the specific pieces of Personal Information we have collected about you in the preceding 12 months.</li> <li>• <b>Right to Deletion.</b> You have the right to request that we delete the Personal Information we collect from you. However, in certain situations we are not required to delete your Personal Information, such as when the information is necessary in order to complete the transaction for which the Personal Information was collected, to provide a good or service requested by you, to comply with a legal obligation, to engage in research, to secure our websites or other online services, or to otherwise use your Personal Information internally in a lawful manner that is compatible with the context in which you provided the information.</li> </ul>

Therefore, if you exercise your right to notice, right of access, or right to deletion, we must first verify your identify to make sure that you are the person about whom we have collected Personal Information. We verify every request carefully. Along with your request, we ask that you provide your email address. We may also ask that you provide us with a scanned copy of your government-issued ID or some other form of identification or residency verification.</p> <p>You may also authorize someone else to submit these requests on your behalf. To do so, you may designate directly with us another person who may act on your behalf by providing us with a notarized copy of power attorney or ask the authorized agent to provide us with a copy of your written permission and a scanned copy of their own government-issued ID.</p>
<p><b>Financial Incentives</b></p>	<p>You have the right to be free from discrimination or retaliation for exercising any of your rights under the CCPA. We may, however, charge a different price or rate, or provide a different level or quality of goods or services to you, if that difference is reasonably related to the value provided to Sumitomo Pharma Oncology, Inc. by your Personal Information. Further, we may offer you financial incentives in return for your Personal Information.</p>
